# **Must Read**

#### The new BC Societies Act:

## > Why a new act?

- > The original Society Act largely unamended since enactment in the 1970's
- > Eliminate ambiguity and outdated provisions in old Act
- > Distinguish between societies that exist to serve the public or rely on public funds vs. those that are entirely funded by its members
- > Recommended approach for most societies is to 'transition' without amending bylaws, and then review bylaws and approve amendments at next general meeting

## > New Act effective November 28, 2016

- > Every Society must 'transition' under the new Act by November 28, 2018-similar to how corporations had to transition when the current corporate legislation came in to force in 2005
- > Every Society has to transition by November 28, 2018 or face being "struck" (ceasing to legally exist)

## > Member Funded Societies

- > New category or class called a "member funded" society
- > Is a society that funds itself from its members and not public funds or grants
- > Constitution must state it exists to serve primarily its members
- > Can convert to a for profit company
- > Can distribute assets to Members on liquidation/wind up
- > Will predominantly be Societies that act as a vehicle to own property for the common use of a restricted group
- > Memberships can be transferable ( must be provided for in bylaws)

## **Directors**

- > Society must have 3 directors (only 1 for member funded society)
- > Subject to the Act, Regulations and bylaws, must manage affairs of Society

## **Constitution and Bylaws**

- > Amending a Society's Constitution and Bylaws can put Society offside:
  - Criteria for maintaining charitable status with CRA
  - Security granted to creditors (mortgages of GSAs)
  - Ability to receive gaming grants if amendment puts the Society offside the Ministry's gaming grant guidelines

## **New Flexibility**

- > Timing of AGMs— simply need to be held once a calendar year, no requirement to be held within 15 months of prior AGM
- > Membership- new, clear provisions providing for:
  - discipline or termination of a member
  - different classes of members
  - specific criteria for admission as member
  - memberships to be transferrable (must be provided for in bylaws)

## **Director Qualifications**

- > Cannot be or have been:
  - found by any court to be incapable of managing the individual's own affairs,
  - an undischarged bankrupt
  - convicted of an offence in connection with the promotion, formation or management of a

Corporation or unincorporated entity of an offence involving fraud

13. BC Societies Act: Member Funded Society

#### Preamble:

The BC Societies Act has created a new concept that did not exist under the former legislationit differentiates between publicly funded societies and "member funded" societies. A member
funded society is a society that is funded primarily by its own members to carry on activities for
the benefit of its members. Sports clubs are anticipated as the types of organizations intended
to fit into this new category. A resolution must be obtained from its members at the time of transition
or must obtain court approval to become a member funded society after transition.

The following statement must be included in the Constitution.

This society is a member-funded society. It is funded primarily by its members to carry on activities for the benefit of its members. On its liquidation or dissolution, this society may distribute its money and other property to its members Motion: Be it resolved that Vernon Yacht Club is a Member Funded Society.





## **Important Notice to All Members:**

#### STANDARDS FOR SECURING BOATS AT VERNON YACHT CLUB MARINA



The mooring standards as presented below are designed to prevent damage to your boat, the docks and other boats. You are required to use appropriately sized mooring lines with snubbers or spring steel on lines of less than 10 feet in length. A properly secured boat will be held by **a minimum of three lines**. Attach lines correctly to cleats and keep snug so lines do not droop into the water. Use fenders to prevent contact of your boat with the dock or other boats.

#### Terminology:

**Bow** – the forward part of a boat.

**Bow Line** – a docking line leading from the bow.

Chafing Gear – tubing or leather wrapping used to

protect a line from chafing on a rough surface.

**Cleat** – the metal fixture on the dock (or on your boat) used to attach lines to securely moor your boat.

**Fender** – a cushion, placed between boats, or between a boat and a dock, to prevent damage.

**Line** – nautical term for ropes used in sailing and securing your boat to a dock.

**Pile** – a wood, metal or concrete pole driven into the ground.

**Snubber** – a rubber or spring steel device attached to a mooring line to reduce shock to the boat and the dock.

**Spring Line** – a line used to prevent the boat from moving forward or backward while made fast to a dock.

**Stern** – the after or back part of a boat.

**Stern Line** – a docking line leading from the stern.

#### Lines can generally be categorized as follows:


**Laid Nylon** – a twisted line of nylon fibers may be used as a mooring line.

**Single Braided or Double Braided Nylon** (braided core covered with braided jacket) – are the best lines for moorage as they have good abrasion resistance and resistance to rot.

Polypropylene (the common yellow or white ski rope) – must NOT be used as a mooring line.

#### Size of line recommended for size of boat:

Boats to 20 feet = 3/8 inch diameter line Boats 20 to 35 feet = 1/2 inch diameter line Boats 35 to 45 feet = 5/8 inch diameter line



# **Proper Towing of Boats and Trailers**

The improper towing of boats can create dangerous driving conditions resulting in traffic accidents.

## When towing a boat or trailer:

- Ensure that the tires on the trailer and tow vehicle are properly inflated.
- Connect safety chains properly.
- Make sure that your boat is properly secured to the trailer.
- Check that the trailer's signal lights and brake lights are operating properly.
- Ensure that the trailer is properly secured to the trailer hitch.
- Secure and contain all equipment and cargo. This will keep it from shifting within the boat which can affect stability or falling out into traffic.
- Allow for more space between yourself and the vehicle ahead of you. The added weight will increase the stopping distance required.
- If you are traveling for an extended period stop in a safe location to make sure brake lights and signal lights are still working properly.

Exercise caution when passing another vehicle. The added weight of the boat can dramatically reduce acceleration.
